**NOTICE UNDER SECTION 708A OF THE CORPORATIONS ACT 2001**

Gascoyne Resources Limited ("**Gascoyne**" or the "**Company**") has issued 11,000,000 fully paid Gascoyne shares (**Consideration Shares**) as part consideration for the acquisition of the remaining 20% interest in the following mineral tenements:
