Issue of Performance Rights

Gascoyne Resources Limited (“**Gascoyne**” or “**Company**”) (ASX:GCY) advises that it has issued performance rights to two of its key management personnel in accordance with their employment contracts and the GCY Equity Incentive Plan Rules (“**Plan**”).

Terms of Issue.

Two classes of performance rights have been issued, both of which are subject to the Plan.

200,000 Class A Performance Rights and 200,000 Class B Performance Rights have been issued. Each Performance Right conveys to the holder the right convert 1 Performance Right into 1 fully paid ordinary share in Gascoyne.

Class A Performance Rights will vest provided the recipient of the right has been continuously employed by the Company to 1 July 2022 and will lapse on 30 June 2032, if not exercised on or prior to that date. Class B Performance Rights will vest provided the recipient of the right has been continuously employed by the Company to 1 January 2023 and will lapse on 31 December 2032, if not exercised on or prior to that date.

All Class A and Class B Performance Rights have a zero exercise price.

All Class A and Class B Performance Rights which do not vest will lapse immediately.

BACKGROUND ON GASCOYNE RESOURCES

Gascoyne was reinstated on the ASX in October 2020 and is focused on production, development and exploration of a number of gold projects in Western Australia underpinned by positive cash flow generated from the Dalgarranga Operation. In 2020, Dalgarranga produced in excess of 80,000 ounces of gold with targeted production over the next 4 years of between 70,000 and 80,000 ounces of gold per annum.
