This drawdown, combined with proceeds from the \$85.2 million equity raise completed in October 2020, were used to fully repay previous finance facilities and recapitalise the Company.</p> <p>In addition to scheduled principal repayment (\$3.5 million) and quarterly cash sweep (\$0.9 million) during the quarter, on 30 March 2021 the Company made a voluntary debt prepayment of \$14.6 million.</p> <p>Following these payments, the face value of the debt at the end of the quarter is \$17.5 million.</p>
